**TOWN LEVY ESTIMATE FOR FISCAL YEAR
 BEGINNING APRIL 1, 2020 AND ENDING MARCH 31, 2021
 PLAINFIELD TOWNSHIP, WILL COUNTY, ILLINOIS**

WHEREAS, an estimate of taxes to be levied for all town purposes for Plainfield Township, Will County, Illinois for the tax year 2019, collectable in 2020 is to be determined.

NOW THEREFORE, BE IT RESOLVED by the Board of Trustees of Plainfield Township, Will County, Illinois, as follows:

Section 1. That the sum of one million six hundred sixty eight thousand four hundred thirteen (\$1,668,413) is hereby estimated to be levied upon all property subject to taxation within the Township as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Township as required by statute or voted by the people in accordance with the law, for such purposes as the General Town Fund for the year 2020.

Section 2. That the Board of Trustees of Plainfield Township will adopt an ordinance levying the taxes to meet and defray all the necessary expenses and liabilities of the Township at the December 9, 2019 at special board meeting.

WHEREAS, an estimate of taxes to be levied for all road and bridge purposes for Plainfield Township, Will County, Illinois for the tax year 2019, collectable in 2020 is to be determined.

NOW THEREFORE, BE IT RESOLVED by the Board of Trustees of Plainfield Township, Will County, Illinois, as follows:

Section 1. That the sum of two million two hundred thirteen thousand six hundred ninety nine (\$2,213,699) is hereby estimated to be levied upon all property subject to taxation within the Township as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Township as required by statute or voted by the people in accordance with the law, for such purposes as the General Road & Bridge Fund for the year 2020.

Section 2. That the Board of Trustees of Plainfield Township will adopt an ordinance levying the taxes to meet and defray all the necessary expenses and liabilities of the Township at the December 9, 2019 monthly board meeting.
