WHAT TO BRING WITH YOU

1 Personal Information

- Original** Social Security card/ITIN for everyone included on your return
- A valid form of **photo ID**
- Bank routing and account numbers
- Marketplace Health Insurance** (Form 1095-A), if applicable
- If you are married and filing jointly, **both spouses must be present**
- Up to date IP PIN**, if applicable (Identity Theft)

2 Year-End Income Statements

- W-2** from for each job
- 1099-MISC, 1099-NEC or 1099-K** for self-employment income, including cash income, and rideshare work. (Uber/Lyft)
- 1099 forms** for Social Security, retirement, **unemployment**, interest dividends, and stock sales

3 Expenses and Credits

- Educational expenses** paid for children in grades K-12
- Tuition expenses** paid to attend college or university (Form 1098-T)
- Student loan interest paid** (Form 1098-E)
- Childcare expenses:** Bring provider name, address, and tax ID or social security number
- Homeowners:** Bring mortgage interest and property taxes paid
- Self-Employed:** Receipts for expenses

- Seguro médico del Mercado** de seguros (Formulario 1095-A), si corresponde
- Si está casado y presenta una declaración conjunta, **ambos cónyuges deben estar presentes**
- IP PIN** actualizado, si corresponde (robo de identidad)

2 Year-End Income Statements

- Formulario **W-2** para casa trabajo
- 1099-MISC, 1099-NEC or 1099-K** para ingresos de trabajo por cuenta propia, incluidos ingresos en efectivo y trabajo de viaje compartido (Uber/Lyft)
- Formularios 1099** para Seguro Social, jubilación, desempleo, intereses, dividendos, y ventas de acciones

3 Expenses and Credits

- Gastos educativos** pagados para niños en los grados K-12
- Gastos de matrícula** pagados para asistir a la Universidad (Formulario 1098-T)
- Intereses de préstamos estudiantiles pagados** (1098-E)
- Gastos de cuidado de niños:** Traiga el nombre del proveedor, la dirección y la identificación fiscal o el número de seguro social
- Propietarios de viviendas:** Traer intereses hipotecarios e impuestos a la propiedad pagados
