### Exemptions

We are still accepting 2023 new and renewal exemption applications for the Senior Freeze,

### Board of Review

• The Will County Board of Review is expected to publish their 2023 decisions later this month.

### Training

• The Annual Assessor Meeting was held on December 18<sup>th</sup>. The Supervisor of Assessments is required to hold the meeting annually.

#### Assessing

- The 2024 assessment year is a non-quad year. In non-quad years every neighborhood is reviewed. Neighborhood factors will be applied as necessary.
- New construction is expected to continue with a few new developments anticipated.



### Plainfield Township Highway Department Board Report for December, 2023

### WORK UPDATE

- Drainage: Street drains, inlets, and culverts were continually monitored; blockages were cleared to insure proper drainage with the heavy rainfall. Leaves left over from the leaf pickup program were removed from the roads to prevent clogged drains and to prepare for snow plows.
- Road Repairs: Shoulder gravel was added where needed and roads were patched and graded in the Road District when the weather allowed.
- Snow Plowing: Roads and bridges were salted for safety and to prevent skidding.
- Street Signs: Damage signs were replaced/repaired where needed.
- Other Maintenance: Shop and trucks were cleaned; Township Roads were cleared of stray garbage and debris. The crew built room additions to the garage for oil and tools for safety purposes.
- **Equipment:** Normal, preventative truck maintenance was conducted on the fleet and equipment.

#### Notes:

- LIHEAP was here in December.
- Toys for Tots program gave 779 toys to 188 kids from 48 families. The Marine Corps donated 160 toys, and the Plainfield Interfaith Food Pantry donated 619 toys.
- 8 essential food boxes donated from Grace Point Church were also given out to needy families during the Toys for Tots event.
- Met with Lockport and Plainfield Fire about Thriveworks.
- The Township processed 509 passports in 2023. This is an 11% increase from 2022. The Township had a net revenue of \$15,818.80 from passports in 2023.
- Visitors to the township increased by 11% from the previous year for a total of 3,434.
- We are working with the Plainfield Township Library to help accommodate them for additional meeting room space during their renovation.
