Purpose

The Township Board recognizes the need to form an Ad-Hoc Committee to study and make recommendations regarding the Plainfield Township Community Center grassy knoll. This committee will allow the Board to engage in detailed discussion and evaluation of the issue in a transparent and collaborative manner while ensuring full compliance with the Illinois Open Meetings Act (5 ILCS 120/1 et seq.)

Formation and Membership

The Ad-Hoc Committee shall be formally established by action of the Township Board, thereby designating it as a "public body" under the Open Meetings Act. Membership shall consist of the Township Supervisor and all elected Trustees. Additional non-voting members, such as department heads, staff, or community representatives, may be appointed as needed to provide expertise or input.

Open Meetings Act Compliance

Because a majority of a quorum of the Township Board will be participating, the Ad-Hoc Committee shall:

- Comply fully with the Illinois Open Meetings Act (5 ILCS 120/1 et seq.);
- Post public notice of all meetings in accordance with statutory timelines;
- Prepare and post a meeting agenda in advance of each meeting;
- Maintain and approve written minutes of each meeting; and
- Conduct all business in open session except as otherwise permitted under OMA.

All deliberations, discussions, and decisions of the committee will be made in open and public meetings, ensuring transparency and public trust.

Duties and Scope

The committee shall:

- Review, research, and discuss matters related to the future development on the Plainfield Township Community Center grassy knoll area;
- Prepare recommendations and present findings to the Township Board for formal consideration at a regular or special board meeting.

The committee shall have no independent authority to approve expenditures or implement actions on behalf of the Township unless specifically authorized by the Township Board.

Duration

The Ad-Hoc Committee is temporary in nature and shall dissolve upon completion of its assigned task or upon further action of the Township Board.

Recommendation

It is recommended that the Township Board formally adopt a motion or resolution to create the Grassy Knoll Ad-Hoc Committee as outlined above, ensuring that all trustees may participate in the discussion process while maintaining full transparency and compliance with the Open Meetings Act.

WORK UPDATE

- Branch Pickup: The Branch Pickup Program has concluded for 2025.
- **Leaf Pickup:** The Leaf Pickup Program began the week of October 27th. This is a four week program.
- **Drainage:** Street drains were monitored and cleared of debris during the rainfall; Inlets and catch basins were jetted and cleared of debris; Inlets were repaired where necessary.
- Training: The Crew spent time at the Plainfield Township Cemetery, where they were able to
 practice installing culverts and operating equipment; We hosted an Emergency Management
 Response course, delivered by IDOT, where several surrounding Township Highway
 Departments were able to attend.
- Road Maintenance: Shoulder gravel was added at road edges where needed; Easements were hydro-excavated, regraded and landscaped; Rock was added to ditches where needed in areas that are slow to drain.
- Street Signs: Signs were replaced where damaged or worn.
- **Equipment:** Normal, preventative truck maintenance was conducted on the fleet and equipment. Trucks, equipment and shop were cleaned.
- Mowing and branch trimming: Trees were trimmed or removed as needed in Right of Ways.
- Other Maintenance: Garbage was picked up in the right of ways.
- Commissioner's Note: Submitting a No Parking Ordinance for a road within the jurisdictional limits of the Plainfield Township Highway Department.

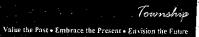

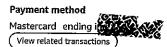

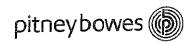
